Section 1. General Information

1.1 Background

Stoney Creek Minor Hockey Association (SCMHA) is a long-standing Youth Hockey Organization that has operated in Southern Ontario for over 60+years. SCMHA is in Stoney Creek Ontario and resides in the Greater City of Hamilton. SCMHA offers all levels of hockey including Rep (A/AE) Hockey, Local League (LL), and Entry Development hockey. Age groups consist of IP to Midget Hockey. Home arenas consist of Valley Park Community Centre in Upper Stoney Creek, and Saltfleet arena in lower Stoney Creek

1.2 Mission Statement

The purpose of the Association is to organize, develop and promote minor ice hockey for the youth of the new City of Hamilton (Stoney Creek), including the opportunity for all Stoney Creek youth to participate in recreational house league ice hockey and Development of and participation in competitive representative ice hockey.

1.3 Nature of RFP

Stoney Creek Minor Hockey Association shall select the vendor(s) whose proposal(s), and oral presentation(s) if requested, demonstrate in Stoney Creek Minor Hockey's sole opinion, the clear capability to best fulfill the purposes of this RFP in a cost-effective manner. Stoney Creek Minor Hockey Association reserves the right to accept or reject proposals, in whole or in part, and to negotiate separately as necessary in order to serve the best interests of the Stoney Creek Minor Hockey Association. This RFP shall not obligate Stoney Creek Minor Hockey Association to award a contract or complete the proposed project and it reserves the right to cancel this RFP if it is in its best interest.

NOTE: RFP contracts will be considered for a 1-year term, with an option for a 2nd year extension dependent on customer satisfaction, product quality and customer service.

1.4 General Selection Criteria

General criteria upon which proposals will be evaluated include, but are not limited to, the following:

- a) Ability to provide apparel/equipment/services by the specified time
- b) Ability to provide apparel/equipment/services that matches the associations preferences
- c) Cost
- d) Perceived Quality
- e) Vendor Requirements
- f) Stoney Creek Minor Hockey Sponsorship
- g) Association Rebate
- h) Vendor reputation

Section 2. Instructions to Bidders

2.1 General

All proposal submissions must be **SIGNED** and submitted prior to the closing date and time noted on each respective solicitation.

Closing time will be considered as 5 PM EST if the time is not specified.

All proposal submissions must be delivered in person to SCMHA Office (Valley Park Director - Mailbox) or mailed to SCMHA P.O.Box

Proposal must indicate the RFP# on the document and/or envelope.

Any questions regarding the specifications, deliverables, and scope of work, discrepancies, omissions or any apparent ambiguities must be submitted prior to the date specified in the Calendar of Events. The request for clarification will be reviewed, and where information sought is not already clearly indicated, the Stoney Creek Minor Hockey Association may issue an Addendum to all bidders. Verbal responses to inquiries cannot modify the Solicitation in any way.

2.5 Changes and Extensions

The Stoney Creek Minor Hockey Association may amend specific sections of the Solicitation at any time during the solicitation process. Should the Stoney Creek Minor Hockey Association issue an Addendum to a Solicitation, the closing date deadline may be extended, if appropriate, to accommodate changes in content.

2.6 Withdrawal Conditions

The bidder may withdraw their proposal at any time prior to the Solicitation closing date and time by submitting a request via email to the following address:

All submitted withdrawal requests will have their receipt acknowledged by email.

2.7 Preferred Pricing Clause

The bidder certifies that the price/rate being charged is not in excess of the lowest price/rate charged to anyone else, including their most favoured customer, for like quality, quantity, timing and under similar terms and conditions of the equipment/services offered on this Solicitation.

2.8 Pricing Terms, Payment Terms and Currency

Pricing shall be fixed and firm for the duration of the Agreement unless otherwise specified in Appendix

- a) All pricing must include costs for packaging, sorting, containers, cartage, shipping, etc..., to Stoney Creek Minor Hockey Association office (or other agreed upon specified address). No separate additional charges will be allowed.
- b) Proposals are to be submitted in Canadian funds.
- c) Association annual rebate is requested on all purchases made by SCMHA, SCMHA Teams, SCMHA Players and families on all SCMHA Apparel.
- d) Rebate totals will account from ALL sales from January 1st, to December 31st of each Calendar year.
- e) Quarterly update report outlining purchases made submitted to Purchasing Director due on April 1st, July, 1st, Oct.1st, Jan.1st
- f) Rebate to be paid out by the 30th of January of each new calendar year
- g) Payment terms will be Net 30 days from delivery date. Early payment discounts will be considered.
- h) Deliveries made after the agreed upon due date will be subject to 5% service fee from the total invoice to SCMHA per day late.
- i) Where quality control has not been implemented and jerseys/socks do not meet the agreed upon sample standard, jerseys/socks will be returned to the vendor for immediate replacement or agreed upon repairs. Should the number of jerseys/socks exceed 7% of the total order, an over and above rebate/reduction of 10% of the total order invoice will be awarded to SCMHA.

2.9 Confidentiality

The information contained in proposals submitted for the Stoney Creek Minor Hockey Association consideration shall always remain confidential.

2.10 Validity Period

Proposals must be valid for consideration for up to 90 days following the proposal submission date.

2.11 Bidder Expenses

Bidders are solely responsible for their own expenses in preparing, delivering, or presenting their proposal and for any subsequent meetings or expenses incurred, if any.
