PLEASE NOTE:

Hockey Canada has implemented a new registry system. Your account from the old system (HCR) WAS NOT carried over to the new system. You must create a new account.

RETURNING PLAYERS REGISTRATION ONLY must register online through the Hockey Canada Registration System (HCR 3.0). [Click Here](#) for step-by-step instructions to create your new HCR account. Once you have created your new account these instructions will also walk you through registering a participant.

You Must complete the Respect in Sport (RIS) Parent version PRIOR to completing the online registration process above. Go to the RIS program to complete <https://omhahockeyparent.respectgroupinc.com/>)

Once parents complete the program (pls select Stoney Creek Minor Hockey Association) an HCR profile will be created, you can then go on the SCMHA online store and register as soon as you have completed the program. Please note, there is a charge of \$12.00 + HST, payable directly to Hockey Canada at the start of the program.

Payment

Payments can be made online through Hockey Canada (HCR) - you will see the options during the checkout process for House League/local league and Representative hockey. Only Credit cards can be processed online or you can click on manual e-transfer and manually submit an e transfer via email to registration@scmha.ca no password required. You will receive an invoice when checking out.

The Rep surcharge fee will be added to the HCR once players make teams. For now, you must choose BASE REGISTRATION and TRYOUT FEE to register for tryouts.
